Members discussed ways to get involved with other community organizations/clubs such as sports teams to increase visibility of BWC and achieve more reach with BWC's mission. Members discussed the importance of educating parents and families on the Social Host Liability Law and putting out prevention-centered information more frequently, if possible.

Evan mentioned that the parties BPD is seeing are much smaller than they have been in the past. He also shared that more students are vaping and consuming marijuana in new ways such as edible products.

Portia mentioned having 'open hours' for activities that are youth centered and give youth an alternative to activities where substances may be present.

It was also suggested that Lisa and Wendy present their SHL / prevention strategies webinar around substance misuse to parents of 9th graders.
